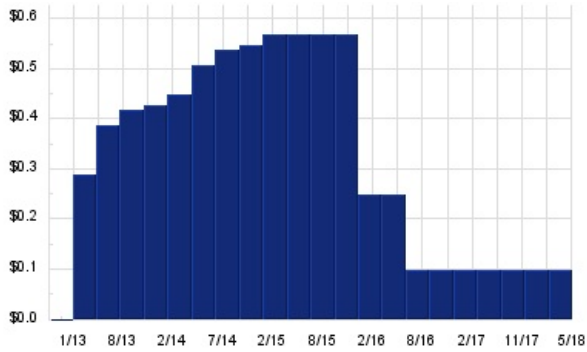

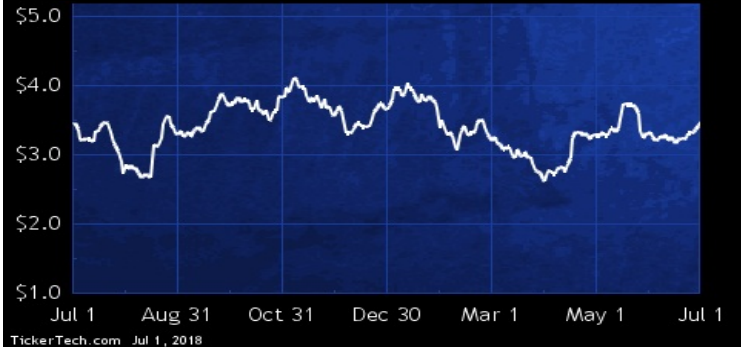

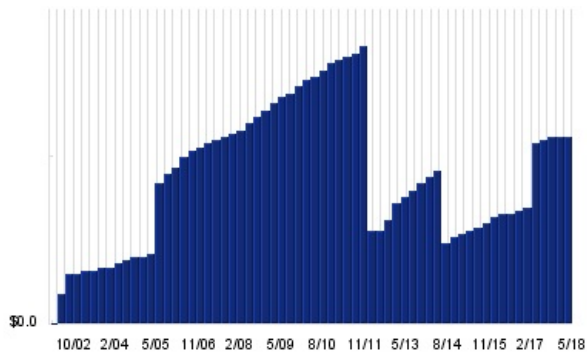


Seadrill Partners is engaged in owning, operating and acquiring offshore drilling units. Co.'s drilling units are under long-term contracts with major oil companies such as Chevron, Total, BP, ExxonMobil and Tullow. Offshore drillings units are categorized in four rigs: jack-up rigs which are mobile, self-elevating drilling platforms equipped with legs that are lowered to the ocean floor; tender rigs conduct production drilling from fixed or floating platforms; semi-submersible rigs operate in a "semi-submerged" floating position; and drillship which are self-propelled ships equipped for drilling in deepwater.

Co. provides natural gas gathering, treating and processing services as well as crude oil and produced water gathering services pursuant. Co.'s segments are: the Utica Shale, which includes its ownership interest in Ohio Gathering and is served by Summit Utica; the Williston Basin, which is served by Bison Midstream, Polar and Divide and Tioga Midstream; the Piceance/DJ Basins, which is served by Grand River and Niobrara G&P; the Barnett Shale, which is served by DFW Midstream; and the Marcellus Shale, which is served by Mountaineer Midstream.

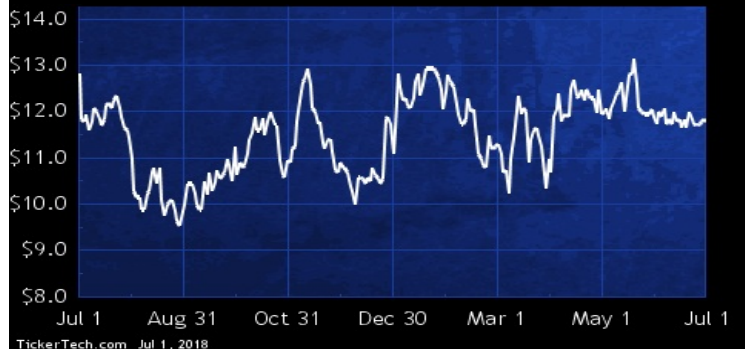

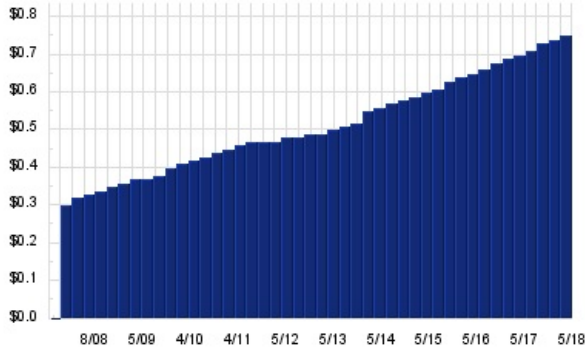


Sanchez Production Partners is focused on the acquisition, development, ownership and operation of midstream and other producing assets in North America. Co. operates in two segments: midstream business, which includes the Western Catarina gathering system; and production business, which includes oil and natural gas reserves in the Eagle Ford Shale in South Texas and in other areas of Texas and Louisiana, as well as properties in the Mid-Continent region. As of Dec 31 2016, Co. had total proved reserves of 6.9 million barrels of oil equivalent, consisting of 3.5 million barrels of oil, 14.6 billion cubic feet of natural gas, and 0.9 million barrels of natural gas liquids.

Co.'s vessels are employed on multi-year time charters, of two years or more, with international energy companies. Co.'s fleet consists of six LNG carriers each with a capacity of 914,100 cubic meters, operating under multi-year charters with BG Group, Gazprom, Yamal and Statoil. Co. owns and operates a fleet of six LNG carriers, consisting of the three LNG carriers in its Initial Fleet, the Clean Energy, the Ob River and the Amur River, and three tri-fuel diesel electric (TFDE) propulsion technology Ice Class LNG carriers.

Co.'s natural gas gathering and compression assets consist of natural gas gathering and compression systems that service producers in the dry gas core of the Marcellus Shale in southwestern Pennsylvania. Co.'s water services assets consist of water pipelines, impoundment facilities, pumping stations, take point facilities and measurement facilities which are used to support well completion activities and to collect and recycle or dispose of flowback and produced water.

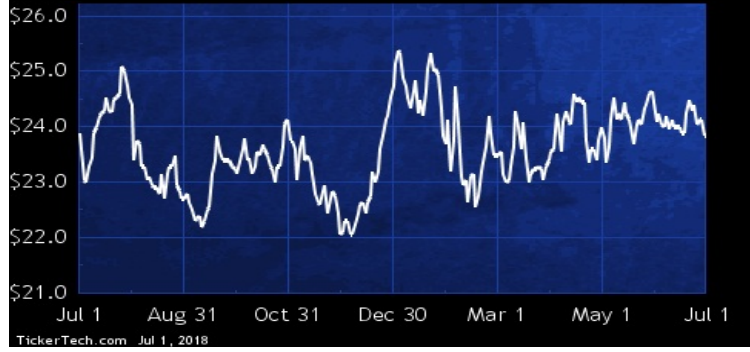

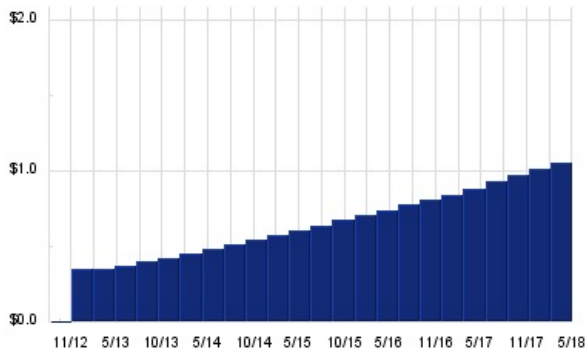


GasLog Partners is a holding company. Co. is a limited partnership formed to own, operate and acquire liquefied natural gas (LNG) carriers engaged in LNG transportation under long-term charters. As of Feb 8 2018, Co. has a fleet of 12 LNG carriers, including seven vessels with TFDE propulsion technology and five Steam vessels. Co. provides services of its ships under time charters. A time charter is a contract for the use of the ship for a specified term at a daily hire rate. Under a time charter, the ship owner provides crewing and other services related to the ship's operation, the cost of which is covered by the hire rate, and the customer is responsible for all of the ship voyage costs.

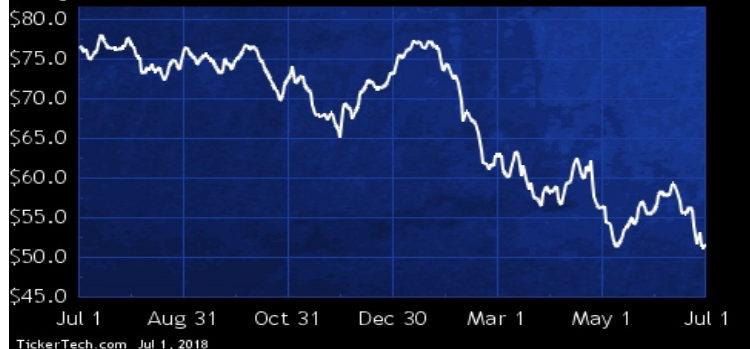
