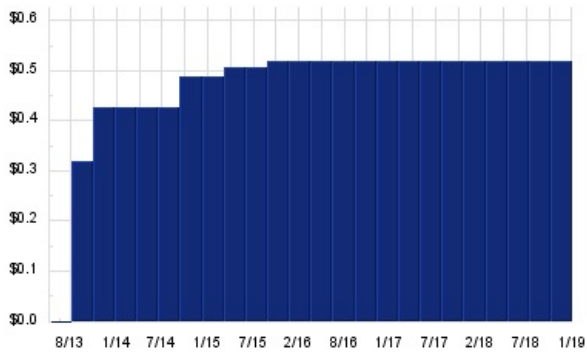

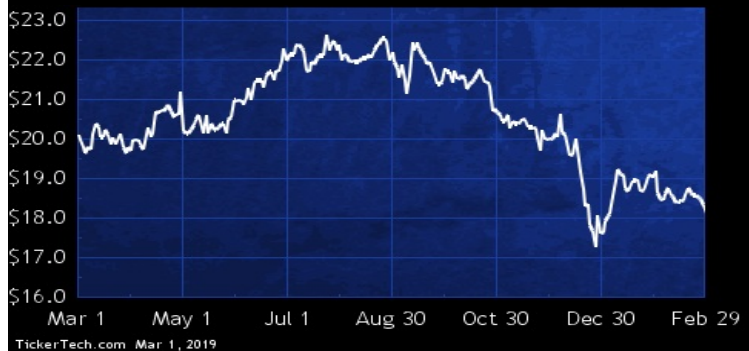

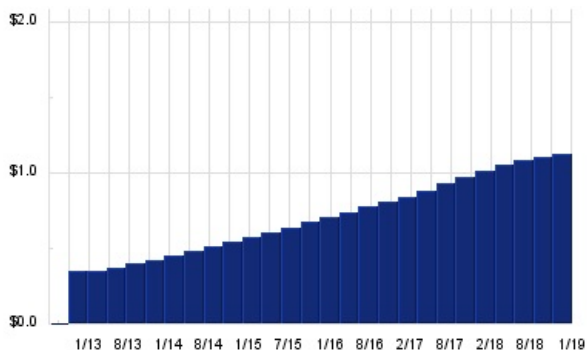


KNOT Offshore Partners is a limited partnership formed to own, operate and acquire shuttle tankers under long-term charters, which Co. defines as charters of five years or more. Co.'s initial fleet of shuttle tankers was contributed to Co. by Knutsen NYK Offshore Tankers AS, or KNOT, which is jointly owned by TS Shipping Invest AS (TSSI), and Nippon Yusen Kaisha (NYK). As of Dec. 31, 2016, Co.'s fleet consists of eleven shuttle tankers. The market for Co.'s services is the offshore oil transportation industry, and Co.'s customers consist primarily of major oil and gas companies, independent oil and gas producers and government-owned oil companies.

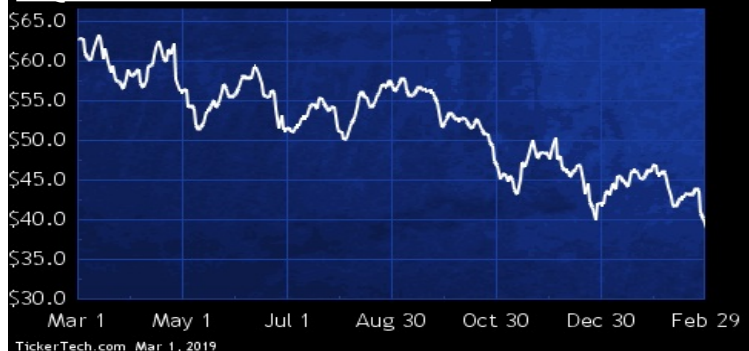

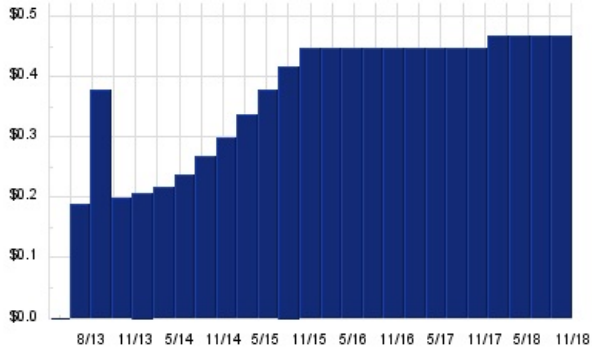


EQM Midstream Partners operates, acquires and develops midstream assets in the Appalachian Basin. Co. provides midstream services to its customers through three primary assets: the gathering system, which delivers natural gas from wells and other receipt points to transmission pipelines; the transmission and storage system, which delivers gas to local demand users and interstate pipelines for access to demand markets; and the water service system, which consists of water pipelines, impoundment facilities, pumping stations, take point facilities and measurement facilities that support well completion activities and collect flowback and produced water for recycling or disposal.

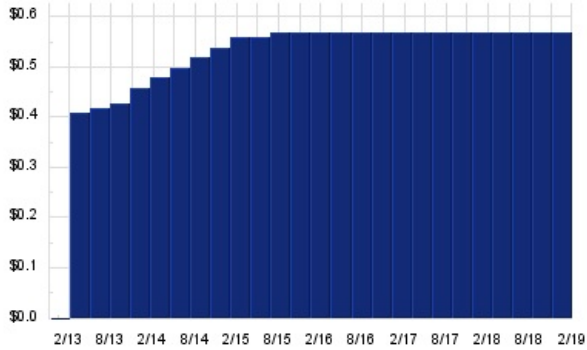


Seadrill Partners is engaged in owning, operating and acquiring offshore drilling units. Co.'s drilling units are under long-term contracts with major oil companies such as Chevron, Total, BP, ExxonMobil and Tullow. Offshore drilling units are categorized in four rigs: jack-up rigs which are mobile, self-elevating drilling platforms equipped with legs that are lowered to the ocean floor; tender rigs conduct production drilling from fixed or floating platforms; semi-submersible rigs operate in a "semi-submerged" floating position; and drillship which are self-propelled ships equipped for drilling in deepwater.

Co. is primarily engaged in the ownership, operation and management of vessels in the LNG market, providing maritime services for the transportation of LNG on a worldwide basis and LNG vessel management services. Co. conducts its operations through its vessel-owning subsidiaries and through its vessel management services subsidiary. Co.'s owned fleet consists of 27 owned LNG carriers, including 22 ships on the water. Co.'s operations are carried out from offices in Piraeus, London, New York, Singapore and Monaco.

GasLog Partners is a holding company. Co. is a limited partnership formed to own, operate and acquire liquefied natural gas (LNG) carriers engaged in LNG transportation under long-term charters. As of Feb 8 2018, Co. has a fleet of 12 LNG carriers, including seven vessels with TFDE propulsion technology and five Steam vessels. Co. provides services of its ships under time charters. A time charter is a contract for the use of the ship for a specified term at a daily hire rate. Under a time charter, the ship owner provides crewing and other services related to the ship's operation, the cost of which is covered by the hire rate, and the customer is responsible for all of the ship voyage costs.

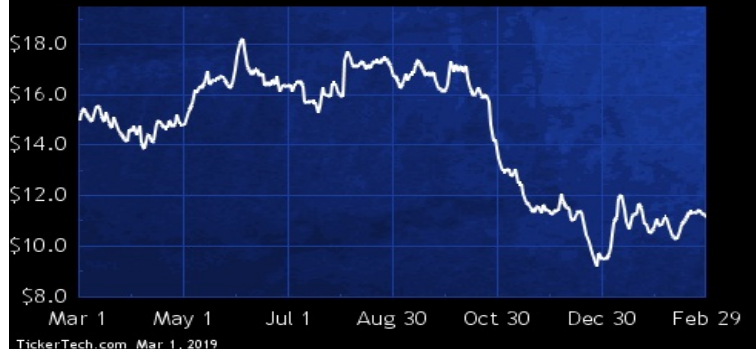

ENLK primarily focuses on providing midstream energy services, including: gathering, compressing, treating, processing, transporting, storing, and selling natural gas; fractionating, transporting, storing, and selling natural gas liquids; and gathering, transporting, stabilizing, storing, trans-loading, and selling crude oil and condensate, in addition to brine disposal services. Co.'s midstream energy asset network includes, among others, natural gas processing plants, fractionators, barge and rail terminals, product storage facilities, and brine disposal wells.
