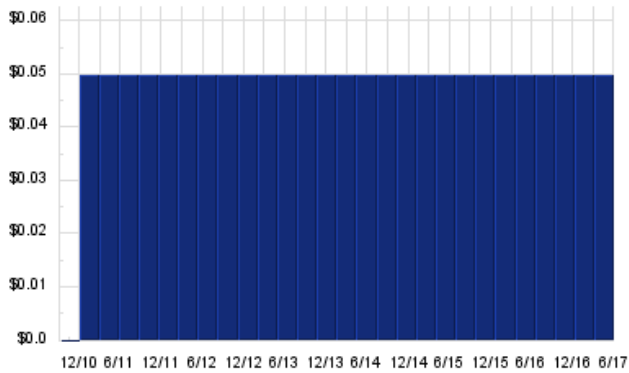

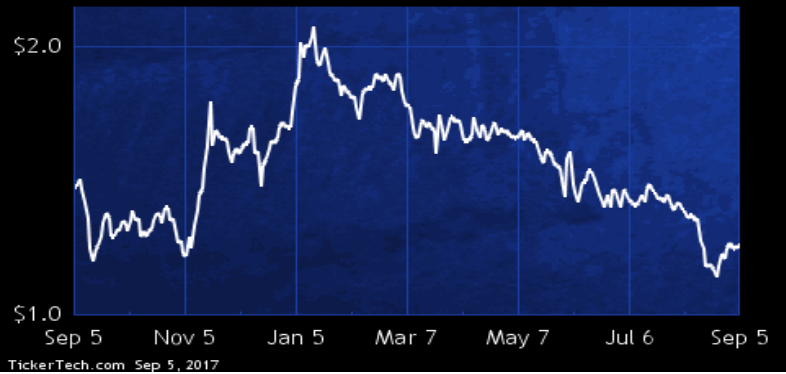

Navios Maritime Acquisition Corp

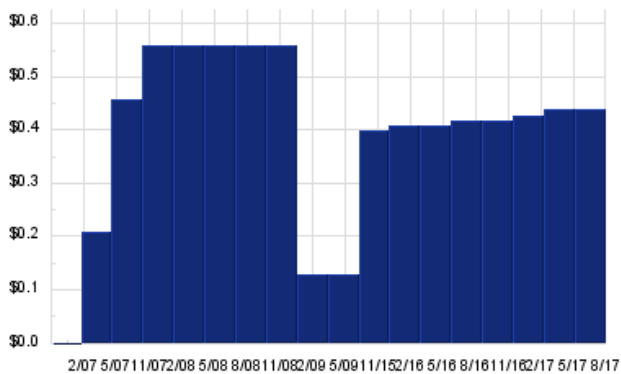


Navios Maritime Acquisition is an owner and operator of a fleet of modern crude oil, refined petroleum product and chemical tankers providing world-wide marine transportation services. Co. charters its vessels to international oil companies, refiners and large vessel operators under long, medium and short-term charters. Co.'s fleet consists of approximately 36 double-hulled tanker vessels, aggregating approximately 3.9 million deadweight tons, or dwt. The fleet includes: 8 VLCC tankers, which transport crude oil; 8 Long Range 1 product tankers; 18 Medium Range 2 product tankers; and 2 chemical tankers, which transport refined petroleum products and bulk liquid chemicals.

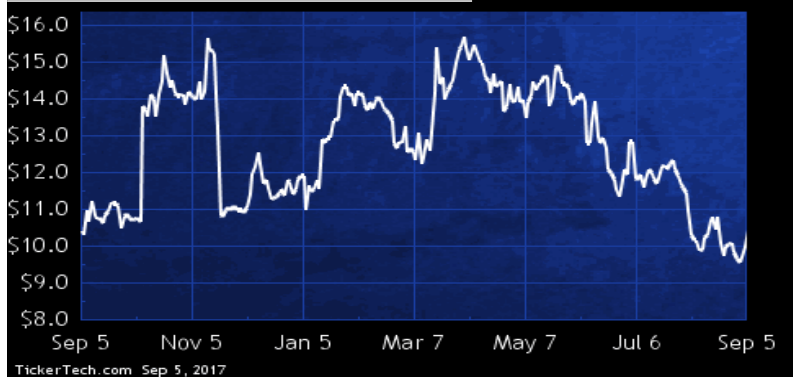

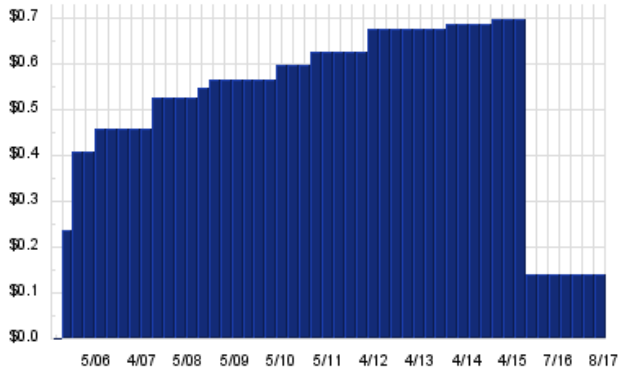


Sanchez Midstream Partners is focused on the acquisition, development, ownership and operation of midstream and other energy producing assets. Co. operates in two segments: midstream business, which includes the Catarina gathering system; and exploration and production business, which includes oil and natural gas reserves in the Eagle Ford Shale in South Texas and in other areas of Texas and Louisiana, as well as properties in the Mid-Continent region. As of Dec 31 2016, Co. had total proved reserves of 6.9 million barrels of oil equivalent, consisting of 3.5 million barrels of oil, 14.6 billion cubic feet of natural gas, 0.9 million barrels of natural gas liquids.

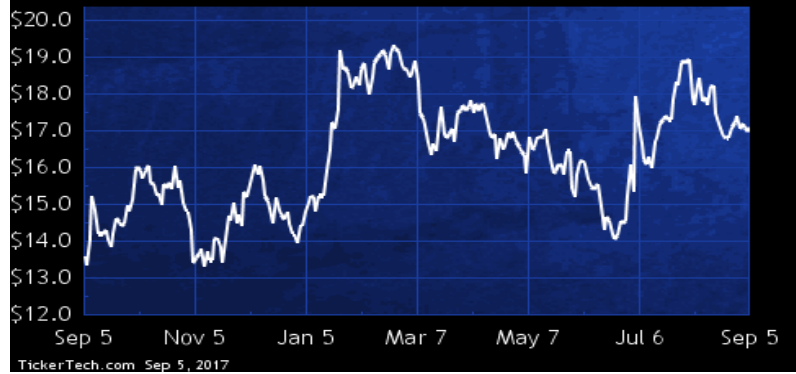

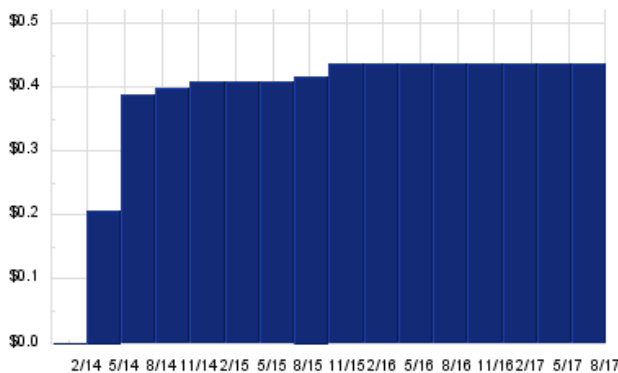


Teekay LNG Partners is a holding company. Co. is an international provider of marine transportation services for liquefied natural gas (LNG), liquefied petroleum gas (LPG) and crude oil. Co.'s fleet consists of 31 LNG carriers (including the six MALT LNG Carriers, four RasGas 3 LNG Carriers, four Angola LNG Carriers, and two Exmar LNG Carriers that are all accounted for under the equity method), 25 LPG carriers (including the 19 Exmar LPG Carriers that are accounted for under the equity method), five Suezmax-class crude oil tankers, and one Handymax product tanker, all of which are double-hulled. LPG shipping transports liquid petroleum gases, petrochemical gases and ammonia.

Seadrill Partners is engaged in owning, operating and acquiring offshore drilling units. Co.'s drilling units are under long-term contracts with major oil companies such as Chevron, Total, BP, ExxonMobil and Tullow. Offshore drillings units are categorized in four rigs: jack-up rigs which are mobile, self-elevating drilling platforms equipped with legs that are lowered to the ocean floor; tender rigs conduct production drilling from fixed or floating platforms; semi-submersible rigs operate in a "semi-submerged" floating position; and drillship which are self-propelled ships equipped for drilling in deepwater.

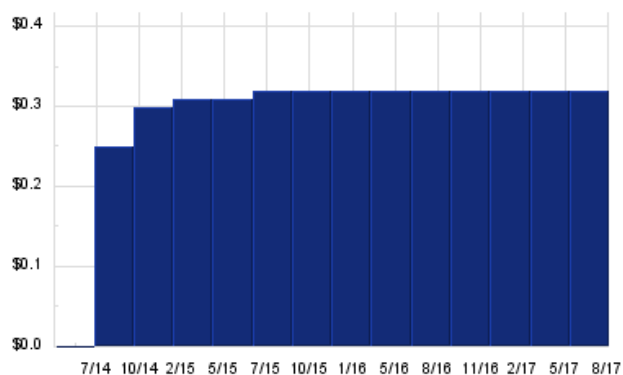


Ship Finance International is an international ship and offshore asset owning and chartering company. Co. operates through subsidiaries, partnerships and branches located in Bermuda, Cyprus, Malta, Liberia, Norway, Singapore, the United Kingdom and the Marshall Islands. As at Apr. 13, 2017, Co.'s assets consist of 14 crude oil tankers, 22 dry bulk carriers, 22 container vessels (including two chartered-in 19,200 TEU vessel), two car carriers, two jack-up drilling rigs, two ultra-deepwater drilling units, five offshore support vessels, two chemical tankers and two newbuilding oil product tankers. Co.'s oil tankers, chemical tankers and oil product tankers are all double-hull vessels.

KNOT Offshore Partners is a limited partnership formed to own, operate and acquire shuttle tankers under long-term charters, which Co. defines as charters of five years or more. Co.'s initial fleet of shuttle tankers was contributed to Co. by Knutsen NYK Offshore Tankers AS, or KNOT, which is jointly owned by TS Shipping Invest AS (TSSI), and Nippon Yusen Kaisha (NYK). As of Dec. 31, 2016, Co.'s fleet consists of eleven shuttle tankers. The market for Co.'s services is the offshore oil transportation industry, and Co.'s customers consist primarily of major oil and gas companies, independent oil and gas producers and government-owned oil companies.
